

Cancel my policy

AIA Super USE THIS FORM FOR CANCELLATION OF ENTIRE POLICY

The cancellation of your insurance policy, and the protection it provides you, could be irreversible. You should consider your current health status, age and financial position as you may be unable to obtain the same cover or may even have to pay substantially more if you require protection in the future. You may be subject to health assessment and acceptance by the insurer, and you may not qualify for cover if you decide to restart your cover in future. When you cancel, we will stop deducting premiums from your account. After your cover has been cancelled, you should be aware you will not be able to make a claim for a condition that arises after the cover is cancelled. If you are replacing your cover with alternative cover, you should not cancel until the replacement cover is in place.
